Terms & Conditions

1. Rates:

Exclusive Use

The Barn only - Full Day - \$200 or Half Day - \$120 Outdoor arena only - Full Day - \$180 or Half Day - \$100 All facilities (The Barn + Outdoor arena) - Full Day - \$350 or Half Day - \$250

Casual

\$20 per hour per horse (2 maximum)

Exclusive use will also incur a security bond of \$250. Payments must be made in advance online:

- 2. For casual hire to individuals, only two horses are allowed at one time in the arena and safe practice to be maintained at all time.
- 3. For exclusive use hire, deductions from the bond will only occur if: venue equipment or fittings are damaged or broken extra cleaning is required (including kitchen area, bathrooms or equipment) you remain within the venue outside the booked period rubbish is left inside and/or outside the venue any other breach of these conditions which results in call out charges or other costs. All costs attributable to any damages by the Client will be recovered in full and any damages shall be repaired to the satisfaction of both parties. If all these conditions are satisfied in full, then the Bond shall be refunded.
- 4. All riders must supply their own correct Personal Protective Equipment worn at all times i.e. closed in shoes, a helmet that is in good condition, and meets the standards for Pony Club use.
- 5. Whilst we understand accidents happen, any damage caused by you, your horses, or people on site for your clinic will be invoiced for.
- 6. Please leave all facilities as you found it.
- 7. Every rider must clear your horse faeces from the barn, arena, yards, car park area. There is a wheelbarrow and forks provided outside the arena near the hay shed at the arena entrance. Please empty it in the dung pile on the side of the hayshed.
- 8. All people accept that they enter the property at their own risk. We do our best to maintain our property. Hazards are listed on the barn wall noticeboard as you enter. If you spot a new hazard, please let us know.
- 9. Courteous behaviour towards other users, resident horses and neighbours is expected at all times. This includes not playing loud music or the use of fireworks.
- 10. North Shore RDA reserves the right to ask riders to leave if unsafe or dangerous practices are observed.
- 11. Every rider/user must have signed and returned a liability disclaimer at the time of, or before hire age.

Cancellation Policy

- 1. For cancellations made more than 24 hours before your booking, no cancellation fee will apply.
- 2. For cancellations made inside 24 hours from the time of riding, then full cost of arena booking hire shall apply.

Liability Disclaimer

I, ______ ("Hirer") agree with North Shore RDA to use the horse arena facilities ("Facilities") of the North Shore RDA on the following terms and conditions set out below:

I acknowledge that horseback riding and equestrian sports can be extremely dangerous. Horses, irrespective of their previous behaviour or characteristics, may act or react unpredictably based upon instinct, fright, or lack of proper control by the rider. I/we understand that the following describes some, but not all, of the risk, dangers or conditions inherent in horseback riding and equestrian sports:

- 1. The propensity of a horse to behave in ways that may result in injury, harm, or death to persons on or around them;
- 2. The unpredictability of a horse's reaction to sounds, sudden movement, and unfamiliar objects, person, other animals, or other things;
- 3. Certain hazards such as surface and subsurface conditions;
- 4. Collisions with other horses or objects including the ground, fences, gates, trees, or other obstacles;
- 5. A falling horse landing on its rider;
- 6. Being stepped on, kicked trampled or bitten by a horse;
- 7. Becoming entangled in the stirrups, reins or other gear;
- 8. The potential of a fellow rider to act in a negligent manner that may contribute to an injury to the Hirer or bystanders watching or helping on the ground.

I acknowledge the possibility that I may have an accident while using the Facilities that could injure me. I specifically assume full responsibility for such a possibility.

I am competent to ride horses in the Facilities, and I assume full and total responsibility for the horse I am riding.

I agree that I shall not hold North Shore RDA responsible for any injury suffered by the Hirer as a result of the use of the Facilities.

I agree that I shall not hold North Shore RDA responsible for any loss, damage, costs of compensation (either direct or indirect) which may be suffered by the Hirer in relation to use of the Facilities.

I agree to indemnify North Shore RDA against any cost, expense, loss or other liability, which North Shore RDA suffers or incurs in relation to use of the Facilities by the Hirer.

I agree to inform North Shore RDA of any damage to the Facilities immediately upon becoming aware of such damage.
